Because multiple applications may be submitted simultaneously, UW&GS is hereby authorized to assign Exhibitor any available booth location represented on the Official Exhibits Floor Plan.

Exhibitor must remit payment in full for booth space at the time of completing the online Application/Agreement for booth space. Please refer to our website for current booth fee rates.

If you require the use of compressed air and/or plumbing, UW&GS cannot guarantee the available booths will have access.

Upon booth confirmation, Exhibitor must submit the required insurance certificate and additional insured endorsement. We encourage you to visit our website, www.unifiedsymposium.org, to review these forms and requirements.
