_____ **Any representative of SAFE Credit Union Convention Center, ABC, CAWG, or the Unified Wine & Grape Symposium, LLC reserves the right to require you to cease from pouring alcohol during this event if they deem it necessary for any reason.** Directions must be followed immediately.

_____ If for any reason this event needs to be cancelled, CAWG and the Unified Wine & Grape Symposium, LLC, have no financial obligation or other form of liability.
